§ N.N. data protection

In order to fulfil the purposes and tasks of the club, personal data on the personal and factual circumstances of the members of the club are processed in compliance with the requirements of the EU General Data Protection Regulation (GDPR) and the Federal Data Protection Act ("Bundesdatenschutzgesetz", BDSG).

Insofar as the requirements described in the respective regulations are met, each club member has the following rights in particular:

- the right to information under Article 15 GDPR,
- the right to rectification under Article 16 GDPR,
- the right to erasure under Article 17 GDPR,
- the right to restriction of processing under Article 18 GDPR,
- the right to data portability under Article 20 GDPR,
- the right of objection according to Article 21 GDPR and
- the right to lodge a complaint with a supervisory authority under Article 77 GDPR.

The organs of the club, all employees or other persons working for the club are prohibited from processing, disclosing, making available to third parties or otherwise using personal data without authorization for purposes other than the respective purpose of fulfilling the task. This obligation also exists after the above-mentioned persons have left the club. © Landessportbund Niedersachsen e.V

A membership is only possible with a SEPA direct debit mandate. The fees will be collected quarterly on February 1st, May 1st, August 1st and November 1st. The membership can only be terminated at the end of a quarter. The termination can only be done via the club office in written form or per e-mail. Entry and termination are only valid when confirmed by the club.
